- 2. 2 copies of the complete protocol
- 3. A two-page summary of the protocol (8 copies)
- 4. Questionnaires
- 5. Informed consent forms including patient information sheets (translated versions where necessary)
- 6. For a clinical trial, investigators must submit the investigator brochure, insurance documents, any adverts for the study
- 7. For multi-centre studies you need to submit the decisions of the other ethics committees in other countries.
- 8. Proposed Budget
- 9. A soft copies of all the above to be emailed to kalumuzi1@gmail.com, mwale.edna@gmail.com ,sydneymwanza@yahoo.co.uk

The submission payment is as follows:

- 1. Three thousand Five hundred kwacha (**K3 500**) for expedited review.
- 2. Two thousand Five Hundred kwacha **(K2 500)** for PhD programs and normal review.
